#### **Election Administrator's Decision**

Decision# 2023/1

The attached complaint was received as timely and met requirements of an official complaint under the CSU regulations.

The complainant, who has asked to remain anonymous, alleges that the respondent, who is running for Vice-President, Equity and sustainability, used a Capilano University logo in his campaign poster contrary to CSU Procedure BD-06.1 (Elections). A photo of the poster was attached to the complaint. The poster includes a picture of the respondent wearing a T-shirt with the logo of the Capilano University Blues, the university sports team. No other logos associated with the university are included on the poster.

The relevant section of the Procedure reads as follows:

Using the logo of the Capilano Students' Union, Capilano University, or a national or provincial student organization, or of any of their services, divisions, departments, or student groups, so as to suggest an organization's endorsement of the candidate's campaign [emphasis added]

The rule is clear that use of a logo does not violate the rules unless it suggests endorsement. In the present case, no one is likely to infer that the candidate has been endorsed by the university sports team or any university-related organization because of the T-shirt he is wearing in the photo. Accordingly, the poster does not violate the rule and the complaint is dismissed.

I note that the complainant has 48 hours from the time they receive this decision to submit an appeal in the manner set forth in CSU Regulation BD-06.1.
