Election Administrator's Decision

Decision# 2023/2

The attached complaint was received as timely and met requirements of an official complaint under the CSU regulations.

The complainant alleges that the respondent, Sahil Sahil, a candidate for vice-President Equity and Sustainability, improperly posted a campaign poster on bulletin board No. LB 03-031.

Election Procedure BD-06.1 (Elections) provides:

Permitted Campaign Materials and Activities

• • •

- 1) The following physical campaign materials are allowed:
 - a) Posters (up to tabloid size), with a limit of one poster per bulletin board, and subject to any Capilano Students' Union or university postering rules; any unconventional materials affixed to a bulletin board will be considered to be the one permitted "poster" per board;

CSU ha circulated a list of bulletin boards on which it forbidden to post and bulletin board No. LB 03-01 is not on that list. Nor is there anything else about this board, such as a sign that it is restricted for some purpose, that would prevent the candidate from posting. It is also relevant that the respondent has posted a single poster of a permitted size and has not covered up any other posters with his. Accordingly, it has not been established that any violation of the rules has occurred in this case.

I note that the complainant has 48 hours from the time they receive this decision to submit an appeal in the manner set forth in CSU Regulation BD-06.1.


