#### **Election Administrator's Decision**

Decision #2023/7

The attached complaint was received as timely and met requirements for an official complaint under the CSU regulations. As the complainant expressed a wish to remain anonymous, information identifying them has been redacted.

The complainant alleges that several candidates were slating (i.e. running together as a group) contrary to Election procedure BD-06.1. In support of this allegation the complainant submitted two screenshots of SMS messages that include the names of a number of candidates for various CSU offices. The name of the sender of the SMS has been blocked out in the screen shot.

I contacted the complainant and they were not able to provide any further evidence to support the allegation of slating.

Candidates running as a group is against the rules, However, in this case, there is not enough evidence to reach any conclusion about what happened. In particular, since it is not clear that any of the candidates created or sent this SMS, it is not clear that any slating has occurred.

Accordingly, the complaint is dismissed.

The complainant has 48 hours from the time they receive this decision to submit an appeal in the manner set forth in CSU Regulation BD-06.1.
